 - 4.1 TAG/Ambulance Contract Implementation Current
 - 4.2 Legislation AB1129 Elite changeover target date is 9/1/16. This provides mobile data entry for Fire and a single unified PCR.
 - 4.3 Number of runs by hospital Will be distributed via email when received.
 - 4.4 Hospital Diversion New policy was a collaborative effort. Policy becomes effective 3/1/16. Key changes include a two hour limit and a 2 hour refractory period.
 - 4.5 EMS/HIE Grant Proposal Did not pursue this grant due to the necessity to tie into San Diego's HIE and the long term costs associated with that. The plan is to still move forward with HIE locally.
