- 1.0 Approved minutes of March. Meeting called to order by Jessica Randolph at 8:32 am at Watsonville Community Hospital.
- 2.0 Written Correspondence None.
- 3.0 Oral Communications Dr. Yellin discussed a group of patients from the Behavioral Health Center that have dual diagnosis and are sent to the hospitals when they really don't need Emergency Department care. Their needs could be better addressed at an intermediate facility. It was moved to add this item the Agenda for the next EMCC meeting for discussion.

 - 4.3 Hospital Diversion Dr. Ghilarducci reported that there have been no problems since the implementation of the new policy on 3/1/2016.

- 5.0 Consultant for RFP A consultant has been selected and the goal is to get a contract to the Board of Supervisors in May 2016.
- 6.0 EMS Administrator Recruitment A selection has been made and the paperwork is being finalized. Letter to applicants who were not selected are being sent out. Official announcement will be made when all the details are finalized.
- 7.0 Vacancies on Commission Dr. Hernandez spoke with Will O'Sullivan and forwarded him information for his review. There is still one vacancy.
- 8.0 Prehospital Advisory Committee Dr. Ghilarducci reported that the PAC is working on performance metrics to improve process. Dr. Yellin reported that Dominican is currently undergoing remodeling and at times is down 2 to 4 beds in the Emergency Department. Dr. Ghilarducci also reported that Emergency Preparedness has an intern available to work on the formatting and beautification of the MCI Plan; he's working on the Ambulance Mitigation Plan and will have a field guide ready before summer; and discussed changing the day of the EMCC meetings to consolidate with other meetings such as PAC.
