

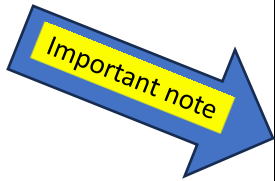

Example: LPHA is determining Medical Necessity or updating treatment plan and/ or MD/NP/PA is documenting medical review.

If 31 minutes or more = 90885 If 30 minutes or less = T1017
