Report to manage data needs some more work, for example: add program parameters, date ranges, formatting, math and category calculations. David and Gian will work on proposed changes If priority choices are needed, the group recommends to invest time in updating the form rather then training in the interim form, to avoid gaps between training and using the form.

Netsmart is looking to see which update includes the form to identify which upgrade to install to have the form available

Including:

- o Detailed information,
- o Identify workflow changes,
- o Discuss how to prepare,
- Make a implementation target date and plan
- Review current data:
 - By Legal Entity (and program) separate and count notes written in 3 categories:
 - Age of note, calculated by Final Date Service Date: (0-6 days, 7-10, 11+)

Organizational change to stress that notes are important, for complete, safe and accurate clinical record, no just for billing.

Streamlining note writing, what is valuable and what is extra, making sure it addresses the treatment plan

Are notes taking longer than 10 - 15 minutes to write?

Need to revising creation of: Supervision training - toolkit

Incorporate the use of Progress Note Aging summary report, currently in test mode, to the workflow which show, number and % of notes that are 1-7 days old, 8-10 and 11+,

Need to make the aging calculation match the way the state calculates, the first day as 1 and not 0. change the math to "Final date" - "Service Date" +1

Deployment plan:

- 1) Warning that the expectation is changing QI Info Notice
- 2) give data to the organization to make sure they are supported Data parsed out by Legal Entity
- 3) requirement goes into effect
