  - No longer funded through MHSA during FY 25–26
  - Still providing services with different funding
- *Telos Crisis Residential (CSS)*
  - Encompass opted to end contract
  - Loss of 10 MH Crisis Residential beds
  - BHD staff vetting potential

# FY 2025–26 MHSA Plan Update – Changes to the Plan

## Services Moved within the Plan:

- *Access Services*
  - Moved from CSS Workplan 6 to PEI Workplan 6 for FY 2025–2026
  - PEI Workplan 6 focuses on Access and Linkages to Treatment
- *Crisis Residential (El Dorado Center)*
  - Moved from Workplan 8 to Workplan 6
  - Workplan 6 covers Enhanced Crisis Services and EDC shifted operations to a Crisis Residential program.
